4. Sponsors are responsible to introduce applicants to the Officers, Members of the Board, the Membership Committee and to as many members of the Club as possible throughout this period. Resident applicants and their sponsors are expected to attend "Membership Sunday" on the date specified in their letter of acceptance. Non-Resident applicants are expected to attend if "On-Island."
