- Opti-Race: \$ 100/day Includes: Hull, Blades, Spars and Dolly
- Opti-Club: \$ 50/day Includes: Hull, Spars, Blades, Lines, Sail and Dolly
- 420-Club: \$ 75/day Includes: Hull, Spars, Blades, Lines, Sails and Dolly
- Laser-Club: \$ 75/day Includes: Hull, Spars and Dolly

### SCYC Charter Usage Policy

SCYC makes available fleet assets under following guidelines:

- Members may have use of Club level boats for local regattas at no additional fee, based on availability.
- Non-members who are currently enrolled in sailing program, may have use of Club level boats for local regattas held during program at no additional fee, based on availability.
- Non-members who are currently not enrolled in sailing program have use of Club level boats for local regattas at a normal charter fees, based on availability.
- Sailors who are enrolled in SCYC sailing programs during time of a regatta will have first priority use of club level SCYC charter boats and equipment.

Boat classification:

- Club level boats are used in daily programs and are rigged with basic, non-performance equipment and training sails.
  - Includes club Optis, Sunfish, 420' and Lasers.
- Race Optis are equipped with race ready equipment, hull, blades, spars, dolly, covers.
  - Does not include sail, control lines and sheet.

The Lessee is responsible for all boats and equipment chartered, and assumes all risk for loss and damage to said boats and equipment.

The Lessee shall use the boat and its equipment in accordance with all rules of US Sailing and all rules of the SCYC. The Lessee shall not sublet the boat or its equipment to any other person.

SCYC, in its sole discretion, may charge the Lessee's any amounts needed to repair and/or replace the boat or equipment as a result of damage occasioned during the term of the charter.

The Lessee shall be liable to SCYC for any additional amounts needed to repair and/or replace the boat and/or equipment.

SCYC disclaims all warranties, whether express or implied with regard to the equipment and boat chartered and makes no representations as to the condition of same. Lessee agrees that he/she is leasing the boat and its equipment AS/IS.

SCYC reserves the right to deny anyone the right to charter any boat if, in their sole discretion, they determine that that conditions and/or situations would be unsafe.

The Lessee warrants that the sailor of the boat has sufficient knowledge, experience and skill to properly operate the boat and undertakes this agreement at his/her own risk with full awareness of the inherent dangers of sailing.

The fact that SCYC agrees to Lease a boat and/or its equipment to a Lessee does not imply that the SCYC is qualified to assess and/or is assessing the proficiency of the Lessee and/or sailor regarding boat handling and/or the weather conditions that may be encountered during the term of the charter. SCYC shall not be liable for any bodily injury or property damage to the Lessee and/or sailor during the term of the charter.
